




The number of larger small companies (those with 100-499 employees) that require some or all employees to sign a noncompete or nondisclosure is notably higher than companies with fewer than 10 employees.


The largest small businesses, 100 or more employees, enforce noncompete agreements at four times the rate of the smallest businesses.

Among employer firms, the smallest firms (1-9 employees), 17 percent say they've had trouble hiring a prospective employee due to a preexisting noncompete - that rate doesn't change notably among larger small businesses.










Nearly half of small businesses are subject to some kind of nondisclosure agreements, and this doesn't change significantly as the businesses are larger.




WHICH OF THE FOLLOWING BEST DESCRIBES THE STRUCTURE OF YOUR BUSINESS?



HOW MANY TOTAL FULL-TIME PERSONNEL ARE CURRENTLY EMPLOYED BY YOUR BUSINESS?




